The project proposes Zone Change #23-0007 from A-2-U (General Agriculture within Urban Area) to M-1-U (Light Industrial within Urban Area) as well as Conditional Use Permit #23-0027 to construct and operate a trucking and warehousing operation that will consist of a warehouse totaling 120,245 square feet, 832 trailer parking spaces, 20 truck parking spaces, and 42 car parking spaces.
