NOTICE OF INTENT IS HERBY GIVEN for the preparation of a Negative Declaration Mitigated Negative Declaration for Conditional Use Permit #24-0025 (Initial Study #24-0036) Global Lithium Energy Corp., pursuant to the *California Environmental Quality Act* and the County of Imperial's *Rules and Regulations to Implement California Environmental Quality Act (CEQA) as amended*.

LEAD AGENCY: Imperial County Planning & Development Services Department (ICPDS)

APPLICANT: Global Lithium Energy Corp.

PROJECT LOCATION: 6998 Kalin Road, Calipatria, CA 92233

The project site is is not listed on any list under Government Code Section 65962.5.

PROJECT DESCRIPTION: The applicant proposes a Conditional Use Permit to allow for the drilling of up to two (2) geothermal exploration wells which aim for the testing and evaluation of geothermal resources (thermal and mineral) and to demonstrate the commercial viability of such in the area. The proposed geothermal exploration project consists of up to two (2) geothermal exploration wells with a proposed depth from 500 to 6,000 feet, two (2) 350 by 200 feet well pads, a 300 by 300 feet move on area, all within a fenced footprint of approximately 1,300 by 520 feet area on the southeast corner of the subject property.

PUBLIC HEARING: An Imperial County Planning Commission public hearing will be conducted at a date to be determined, at 9:00 a.m. in the County Administration Center (Board Room) located at 940 Main Street, El Centro, CA, 92243 to consider the adoption of the proposed Mitigated Negative Declaration, in conjunction with the proposed project.


