

## PUBLIC NOTICE

Pursuant to the requirements of the CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) and the County's "RULES AND REGULATIONS TO IMPLEMENT CEQA" the Imperial County Environmental Evaluation Committee will meet on **February 13, 2025** at **1:30 p.m.** in the Board of Supervisors Chambers, 940 Main Street, El Centro, to review the below-mentioned projects:

**Assessment #24-0036: Applicant: Global Lithium Energy Corp.** proposes Conditional Use Permit to allow for the drilling of up to two (2) geothermal exploration wells which aim for the testing and evaluation of geothermal resources (thermal and mineral) and to demonstrate the commercial viability of such in the area. The proposed geothermal exploration project consists of up to two (2) geothermal exploration wells with a proposed depth of 500 to 6,000 feet, two (2) 350 by 200 feet well pads, a 300 by 300 feet move on area, all within a fenced footprint of approximately 1,300 by 520 feet area on the southeast corner of the subject property. The proposed project site is located at 6998 Kalin Road, Calipatria, CA 92233, on property identified as Assessor's Parcel Number 020-120-025-000, and further described as Lots 5, 6 & South Half of the Northwest Quarter of Section 1 & Lots 3, 4 & the South Half of the Northeast Quarter of Section 2, Township 12 South, Range 13 East of the San Bernardino Base and Meridian (S.B.B.M.), County of Imperial; State of California (Supervisory District #4), [Gerardo A. **Assessment #24-0037: Applicant: Imperial County Department of Public Works (ICDPW)** proposes to replace the existing Picacho Bridge over Yuma Main Canal leading into the Townsite of Winterhaven. The proposed Project presents a unique opportunity to construct a modern bridge that implements Best Management Practices (BMPs) concurrently with transportation amenities. Due to cracking and outliving its useful life, the existing wood bridge must be replaced to support commerce, access to the Quechan Reservation, the Bard community, and provide a safer crossing of the Yuma Main Canal. The proposed project is located along Picacho Road in Winterhaven, CA. The bridge lies within APN 056-600-011 with coordinates 32.7358 N, 114.6241 W, and legally described as POR SEC 26 & 35 16-22 LY SWLY OF RR & NELY OF HWY 165.56AC, County of Imperial; State of California (Supervisory District #5), [Luis Bejarano, Planner I at 442-265-1736, or via email at [luisbejarano@co.imperial.ca.us](mailto:luisbejarano@co.imperial.ca.us)].
