

PUBLIC NOTICE

Pursuant to the requirements of the CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) and the County's "RULES AND REGULATIONS TO IMPLEMENT CEQA" the Imperial County Environmental Evaluation Committee will meet on **September 26, 2024**, at **1:30 p.m.** in the Board of Supervisors Chambers, 940 Main Street, El Centro, to review the below-mentioned projects:

(INFORMATIONAL ITEM ONLY) Assessment #24-0009: Applicant: Avantus,LLC. proposes GPA Four (4) Conditional Use Permits (CUPs) with Variances and Zone Change to Renewable Energy overlay; The applicant proposes to develop, design and construct a PV solar energy generation and BESS facility comprised of up to 500 megawatt alternating current (MWac) PV solar and up to 500 MWac of BESS. Power generated by the project would be collected using up to 66-kV collector lines which could run overhead and/or underground to a dedicated Project substation, with a 230-kV overhead generation transmission line or "gen-tie" line linking a Project substation to the IID Liebert Switchyard. The Liebert Switchyard would then be connected to the SDG&E Imperial Valley substation via an overhead 230-kV gen-tie line.

The project, Big Rock 2 Cluster Solar and Storage Project will utilize approximately 1,569 acres that has not been previously entitled, in addition to approx. 867 acres that are currently entitled under active CUPs known as Laurel Cluster 3 (587ac), Laurel Cluster 2 North (120ac) and Laurel Cluster 2 South (160ac) totaling 2,436 ac. Assessment #24-0024: Applicant: Zayo Group LLC. proposes the a new unmanned fiber hut which will house servers and ancillary equipment. The addition will comprise of a prefabricated structure which will be located along Jessup Road, with a footprint of approximately 35' by 23' and a height of 11'11 and an emergency stand-by generator. The project site is located at 1941 Jessup Road, Imperial, CA 92251, on property identified as Assessor Parcel Number 051-120-074-000, and is further described as Parcel 3 PM 1812 of lots 3 4 & 6 section 10 16-12 46.08 AC. on the unincorporated town of Imperial of the County of Imperial; State of California (Supervisory District #3), [Luis Valenzuela, Planner II at 442-265-1736, or by email at luisvalenzuela@co.imperial.ca.us].
