Pursuant to the requirements of the CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) and the County's "RULES AND REGULATIONS TO IMPLEMENT CEQA," the Imperial County Environmental Evaluation Committee (EEC) held a public hearing on **January 9, 2020** at **1:30 p.m.** in the Board of Supervisors Chambers, 940 Main Street, El Centro, CA to hear the project(s) listed below and rendered a CEQA determination(s), e.g., Negative Declaration, Mitigated Negative Declaration or an Environmental Impact Report. (NOTE: Interested parties have ten (10) calendar days to appeal the EEC's CEQA determination from the date of the public hearing).

(Information Item Only) Assessment #18-0020: Applicant: Desert Valley Company (DVC) Monofill Expansion Project (Cell 4) has submitted a project (General Plan Amendment #18-0004, Zone Change #18-0005 and CUP18-0025). The applicant, Desert Valley Company proposes a general plan amendment on parcel 019-100-004-000 from Recreation/Open Space to Government/Special Public and a Zone Change from S-2 (Open Space Preservation) to M2 (Medium Industrial) Zone. The proposed project includes the expansion of the existing DVC Monofill with the addition of waste storage Cell 4 and a new leachate pond, addition and extension of storm-water diversion dikes, minor extension/modification to internal roads, installation of a new water well and additional air quality particulate sampling stations and groundwater monitoring wells. The project site is located at 3301 West Highway 86, Brawley, CA. The project site is located immediately west of the existing monofill on private lands north of Superstition Hills and south of State Route 86, approximately 12 miles west of the city of Westmorland and 4 miles south of the Salton Sea in the County of Imperial. The parcel is identified as Assessor's Parcel Number (APN) 019-100-004-000 and is legally described as being Section 33, Range 11 East, Township 12 South, S.B.B.M and, in an unincorporated area of the County of Imperial. (Mitigated Negative Declaration) Assessment #19-0024: Applicant: Imperial County Public Works Department (ICPWD) Niland Public Safety Facility Project (ICFD/ICSD) has submitted a project, which consists of the demolishing, clearing and grading, and construction of a safety facility that will be shared by Imperial County Fire Department and Imperial County Sheriff's Department and also used for a cooling facility and emergency shelter for the residents of Niland. The Project will be located in the Niland Colonia at 8071 Luxor Avenue, Niland, CA. The parcel is identified as Assessor's Parcel Number 021-111-008-000 and is legally described as being lots 43 to 46 including block 16, townsite of Niland, S.B.B.M. in an unincorporated area of the County of Imperial.
